This letter serves as notice that the Utah Department of Health and Human Services, Office of Licensing ("Office"), in accordance with the settlement signed by the parties, is issuing a new conditional license to Diamond Ranch Academy ("licensee"), and all administrative and judicial appeal rights, as outlined in Utah Code Ann. § 63G-4-101 et seq., have been waived. This new conditional license status supersedes any previous conditional licenses, is effective immediately, and will expire on September 30, 2023 so long as the licensee remains in compliance with conditions placed on the license and with all other applicable licensing rules and statutes.

The following conditions are immediately in effect:

1. Licensee will submit weekly reports on the number of clients who were taken off site to obtain medical care;
2. Licensee will comply with onsite monitoring inspections to ensure compliance, which will occur at least bi-weekly and may be increased or reduced at the discretion of the Office, based on licensee continued compliance;
3. Licensee will notify the Office of all policies that licensee changes;
4. Licensee will submit weekly a current roster of employees to ensure compliance with background clearance requirements;

5. Licensee will submit weekly a report of all new employees who have completed required training; and
6. Licensee will submit reports weekly on licensee's compliance with direct supervision requirements.
